

**FAIRFIELD COUNTY SHERIFF'S OFFICE
PARTICIPANT RELEASE**

The undersigned, referred to as releasor, has executed this participant release as of the date indicated below.

In consideration of releasor being permitted to participate in self-defense training taught by the Fairfield County Sherriff's Office, releasor, for himself/herself and for his/her personal representatives, heirs, and next of kin, releases, waives, discharges and covenants not to sue the Fairfield County Sheriff's Office, its officers and employees, all referred to as releasees, from all liability to releasor, his/her personal representatives, assigns, heirs and next of kin for all loss or damage, and any claim or damage, on account of injury to the person or property or resulting in death of releasor, whether caused by the negligence of releasees or otherwise arising in connection to releasor'sl participation in self-defense training taught by the Fairfield County Sheriff's Office.

Releasor assumes full responsibility for and risk of bodily injury, death or property damage to or by himself/herself due to negligence of releasees that may arise from the releasor's participation in self-defense training.

Releasor agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion of the agreement is held invalid, it is agreed that the balance will, notwithstanding, continue in full legal force and effect.

Releasor, in consideration of being permitted to participate in self-defense training taught by the Fairfield County Sheriff's Office, does for himself/herself, and for his/her heirs, executors, administrators, and assigns, release and forever discharge the Fairfield County Sheriff's Office of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of participation in self-defense training or any activities in connection with self-defense training, whether by negligence or not.

Releasor further states that he/she has carefully read the above release and knows the contents of the release and signs this release as his/her own free act.

Releasor further releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered to him/her during participation in self-defense training.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.

MINOR PARTICIPANT RELEASE

The undersigned, being a parent or legal guardian of the minor child ("Minor") indicated below, hereby makes the following representations: (i) that the undersigned is legally responsible for the Minor and legally empowered to act for, on behalf of, and to execute this Participant Release and thereby bind the Minor; (ii) that the Minor will comply with the rules and regulations and instructions of the Fairfield County Sheriff's Office during the activity (as defined below); and (iii) that the undersigned understands that the risks of the Minor participating in any self-defense training could involve serious injury or death.

In consideration of the Minor being permitted to participate in self-defense training taught by the Fairfield County Sherriff's Office, releasor, for himself/herself and for the Minor and Minor's personal representatives, heirs, and next of kin, releases, waives, discharges and covenants not to sue the Fairfield County Sheriff's Office, its officers and employees, all referred to as releasees, from all liability to releasor, the Minor, the Minor's personal representatives, assigns, heirs and next of kin for all loss or damage, and any claim or damage, on account of injury to the person or property or resulting in death of the Minor, whether caused by the negligence of releasees or otherwise arising in connection with Minor's participation in self-defense training taught by the Fairfield County Sheriff's Office.

Releasor assumes full responsibility for and risk of bodily injury, death or property damage to or by the Minor due to negligence of releasees that may arise from the Minor's participation in self-defense training.

Releasor, on behalf of the Minor, agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion of the agreement is held invalid, it is agreed that the balance will, notwithstanding, continue in full legal force and effect.

Releasor, on behalf of the Minor, in consideration of the Minor being permitted to participate in self-defense training taught by the Fairfield County Sheriff's Office, does for himself/herself, and for the Minor, the Minor's heirs, executors, administrators, and assigns, release and forever discharge the Fairfield County Sheriff's Office of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of participation in self-defense training or any activities in connection with self-defense training, whether by negligence or not.

Releasor further states that he/she has carefully read the above release and knows the contents of the release and signs on behalf of the Minor this release as his/her own free act.

Releasor further releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered to the Minor during participation in self-defense training.

This release contains the entire agreement between the parties to this agreement and the terms of this release are contractual and not a mere recital.
